  - Failure to follow the scheduled service or servicing at non-Perodua service centres.
  - Extreme usage or mileage that exceeds the specified limit.

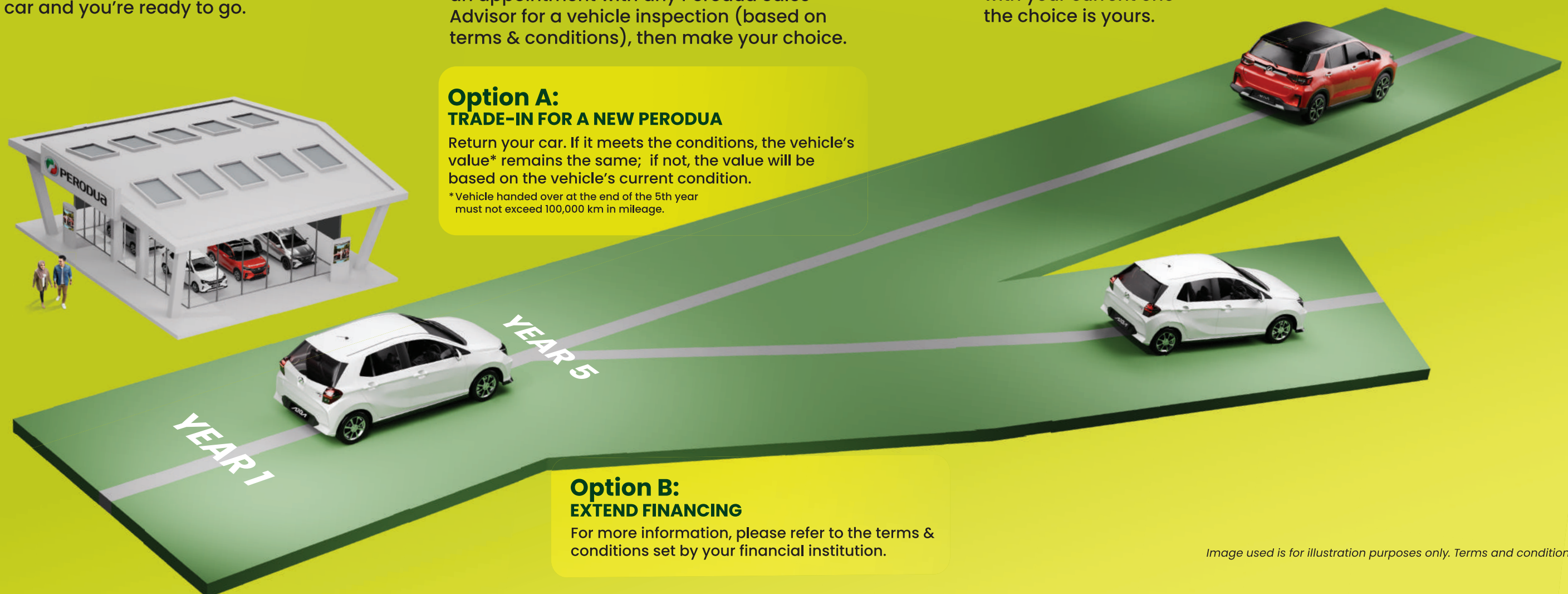
